2025 DE-WINTERIZATION AND STORAGE

Dear Boater:

Good news Big Bear Lake had a decent winter season, and we will be continuing with our current dock configuration (see enclosed map). Better news is that the opening of the 2025 boating season is April 1 and just 4 weeks away, so plan now for the de-winterization and launching of your boat.

For your convenience, enclosed please find copies of the 2025 Pine Knot Marina-De-Winterization Services Rates, the 2025 Pine Knot Marina Service Request Form and Credit Card Authorization form. Should you wish to order repair work, de-winterization of your boat or storage for the 2025 summer season, please fill out the Pine Knot Marina Marine Service Request Form and fax it back to our office at (909) 878-5750 along with your payment information. If you need assistance with your request, please contact the Marina directly at (909) 866-7766, and we will be happy to assist you with all your boating needs.

If you intend to rent a slip at Pine Knot for the 2025 boating season, please remember to fill out your 2025 Facility Rental agreement (previously sent out in December 2024) and submit along with your vessel documentation. Please note before your boat can be launched, we will need a current copy of your certificate of insurance, naming the Dock Club at Pine Knot Landing as additionally insured with a minimum of liability of \$500,000, a current vessel (DMV) registration and a copy of your 2025 Big Bear Lake permit. In addition, if you have umbrella insurance coverage for your boat, we will need a copy of that policy too.

You will be able to purchase the 2025 Big Bear Lake Permits from the Municipal Water District by calling (909) 866-5796 in mid-April or by visiting their website at bbmwd.com. We will NOT be selling permits again this year.

If you need a slip rental agreement, please call the business office at (909) 866-6463. Once completed you can fax the agreement and all your 2025 vessel documentation requirements to (909) 878-5750 or email the dockclub association@gmail.com.

According to the Governing documents for our marina, no boat may be launched or moored within the facility without proper documentation on file at the business office. This requirement applies to both Dock Club members and 2025 slip renters with no exception.


